## Important Schedule Updates

- 1 Carnival Dates: Tuesday through Saturday.
- 2 Mandatory Load-Out: All vendors must be completely moved out by 5:00 PM on Sunday, June 28, 2026.

## Returning Vendors

Returning vendors who wish to retain their previous booth location must submit their completed application and payment by April 15, 2026. After April 15, all remaining vendor spaces will be assigned first-come, first-served.

## Vendor Terms and Conditions

- 1 All vendors must comply with Indiana State Fire Marshal regulations.
- 2 Fire extinguishers required in food booths and near high-heat devices.
- 3 No multiple plug adapters; power strips allowed.
- 4 AC units must be hard-wired by licensed electrician.
- 5 No generators unless approved.
- 6 Health permits and ServSafe certification required for food vendors.
- 7 Vendors must check in and obtain credentials.
- 8 No vehicles in exhibit areas after 4:00 PM.
- 9 Electrical work at vendor expense if required.

- 10 Maintain clean, safe, and professional booth.
- 11 Vendors responsible for Indiana sales tax.
- 12 Insurance required naming Fair Association as additionally insured.
- 13 Fair not responsible for loss or damage.
- 14 All payments non-refundable.
